Tuesday 19 January, 5.00 to 6.30pm: Governance Masterclass for Chairs & Vice Chairs - Part 1

Building an effective Governing Body: How is the Chair's role different to that of the other Governors? Who are your governors? Do they know what they should be doing? How are they performing?

We will start by looking at the skills sets that each Governing Body should have, the key requirements of Governors, performance reviews and how AGBIS's Model Governance Manual for Schools can improve your governance.

Tuesday 26 January, 5.00 to 6.30pm: Governance Masterclass for Chairs & Vice Chairs - Part 2

How do you and your Governors interact with the senior leadership team, in particular the Head? How do you and your Governors use your time?

This session will consider how Chair and Vice Chairs can set the key relationship between the Governors and the SLT on the right course and navigate the fine line between effective oversight and 'meddling' in management. It will also look at how Chairs can best prioritise Governors' time, with reference to agenda setting and committee structures.

Tuesday 2 February, 5.00 to 6.30pm: Governance Masterclass for Chairs & Vice Chairs - Part 3

Do you set aside enough time to look at your School's medium to long term strategy and risk profile? Do you have a handle on how the School is planning to maintain/increase its income streams?

Dealing with the immediate challenges of the covid pandemic is an inevitable priority, nevertheless a key role of the Chair is to ensure that the Governing Body takes ownership of securing and overseeing the long-term sustainability of the School, in particular its financial viability. This last session will look at the Governing Body's role in the oversight of fundraising (and associated data protection considerations), income from the school estate and property development, the use of restricted funds and the associated risk 'red flags' that you as Chair/Vice Chair should be aware of. We will then wrap up with a summary of the top tips and suggested actions from this Masterclass series.

Better boarding provision: a seminar for Governors

Wednesday 27 January or Wednesday 7 July - 10:30am – 3:30pm (lunch break 12.30 – 1.30pm) - £135 per delegate

This one-day on-line seminar is aimed specifically at Governors with responsibility for boarding welfare, and safeguarding, but is also suitable for all Governors who need an in depth understanding around their responsibilities for safeguarding and meeting the needs of boarders at schools with boarding provision. This training day will provide a domestic and international context to the boarding sector and consider the latest challenges facing the boarding sector as a whole, as well as considering the day to day issues boarding staff are working through with the boarders in their care, and with their boarding facilities. Attention will also be given to the role of the boarding and safeguarding Governor, with specific reference to the latest guidance, legislation and research. The responsibilities and duties of Governors are wide ranging, but a sound knowledge of the framework for policy, monitoring and scrutiny will enable effective and confident practice. Similarly, a clear understanding of procedures and policies used by schools will help if Governors are called upon to act in difficult situations.
